TERMS & CONDITIONS

1. The minimum average annual turnover of the bidder OEM Company should be 7.5 crores and for authorized agency of Rs. 1.00 crore in each last three consecutive financial year. Documentary evidence in the form of certified Audited Balance Sheet of relevant period or a certificate from the Chartered Accountant/ Cost Accountant indicating the turnover details for the relevant period shall be enclosed with the bid.
2. The bidder must have the following valid certificates copy which need to be enclosed with the bid:-
 - a) GST certificate with latest GSTR1 Report.
 - b) Bank mandate issued from any nationalized/schedule bank.
 - c) Registration certificate issued by Registrar of Firms.
 - d) PAN Card.
 - e) Audited balance sheet, profit & loss accounts and ITR for last three financial years.
 - f) Company profile.
 - g) ISO 22201 - 1:2017 certificate
 - h) safety & green pro certificate
 - i) TUV certificate
 - j) Trade license certificate
 - k) Solvency certificate worth Rs. 2.0 crores or more (not older than one year)
 - l) Others, as per latest Government Regulation.

3. Upload valid proof for being a "OEM" company or the authorized firm of the "OEM", a latest certificate in original is required in the case of authorization.
4. Availability of Service Centre- Bidder/OEM must have a functional Authorized Service Centre in the State of Bihar preferably in Patna or near side. A detailed address with proof must be uploaded in this support.
5. The company or its Authorized Bidder is expected to have a dedicated/ Toll Free Telephone no. from last 10 years for service support. Documentary proof in this regard is to be enclosed or mentioned.
6. The company or its Authorized Bidder have to submit five similar completed works in Govt./PSU/Institutional Buildings in any last three financial years. Work order or completion certificate should be uploaded in support as documentary proof.
7. In case, the bidder is an authorized distributor/dealer of the OEM then all the required documents of OEM would be applicable for qualification.
8. The L1 bidder will be decided on the basis of total quantity wise evaluation among those who will be qualified in technical evaluation as per our specification and 'T' & 'C' as well as committee recommendation.
9. The company or its authorized bidder should furnish the following undertakings and declarations on its letter head and be enclosed with the bid:-
 - a) Quoted models is of the latest technology and spare parts will remain available for at least five years.
 - b) Product to be supplied & installed should be new branded and as per the exact specification provided in the bid documents.
 - c) The bidder should be a OEM company/partnership firm/proprietorship firm or authorized agency of OEM. No consortium is allowed.
 - d) Acceptance by bidder for two mandatory preventive visits during the warranty period and service men will be available within four hours for technical support & assistance whenever needed on a call/complaint lodged by the dept. Acceptance letter is to be enclosed along with the bid.

- e) The bidder has never been black listed/debarred/suspended by Govt./PSU/institutions/GeM etc. due to any reason In the case of above, the bidder is not eligible to participate in this Bid.
10. The university reserves the right to cancel/reject the bid without assigning any reason thereof.
11. Payment Term:-
- a) 80% of the awarded value on arrival of product invoice (all components) on the site (university premises)
 - b) 20% of the awarded value or actual after successful installation of product and trial of operation.
12. The successful bidder has to provide at least one year comprehensive warranty for all components of the lift and its operational issue.
13. EMD exemption- The bidder seeking EMD exemption must submit valid supporting documents for the relevant category with the bid.
14. Performance Security- The awarded company/firm have to be deposited performance security of Rs. 2,00,000/- before commencement of agreement and would be refunded after warranty period of one year. The OEM company may be relaxed from the performance security and other parts of 'T' & 'C'.
15. EMD & Performance Security should be in shape of DD/FDR or other approved mode in favor of "Registrar, Patliputra University", Patna 800020.
16. Any grievances/request of the firm for the above 'T' & 'C' can be attached with the bid which would be entertained by the university authority.
17. Both of the bid parts (Technical & Financial) shall be in separate sealed envelope and should reached the undersigned office in a single cover sealed envelope by registered post by on or before the stipulated date.
